The Khairahani Municipality has allocated funds from Municipal Assembly towards the cost for Construction of Vegetable and Fruit Shopping Bazaar, Ward No - 6, Khairahani Municipality, Chitwan with estimated cost NRs. 8,118,807.16 (Without VAT) and intends to apply part of the funds to cover eligible payments under the Contract for the Contract ID no: 005/MF/CHT-KMun/NCB/076-077. Bidding is open to all eligible Nepalese Bidders.

2. Khairahani Municipality, Office of Municipal Executive, Chitwan invites sealed bids or electronic bids from eligible bidders for the construction of following projects under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria as per clause of

PPR should participate in this bidding.

A complete set of Bidding Documents may be purchased from the Khairahani Municipality, Office of Municipal Executive, Chitwan by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 3000.00 till 2076-08-04 (20th Nov, 2019) If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 3000.00 However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Sealed or electronic bids must be submitted to the Khairahani Municipality, Office of Municipal Executive, Chitwan by hand/courier or through PPMO website www.bolpatra.gov.np. On or before 12.00 noon on 2076-08-05 (21st Nov, 2019) Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2.00 PM on 2076-08-05(21st Nov, 2019) at the Khairahani Municipality, Office of Municipal Executive, Chitwan. Bids must be valid for a period of 90 days i.e., up to 2076-11-06 (18th Feb, 2020) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs 2, 50,000.00, which shall be valid for 30 days beyond the validity period of the bid i.e. 2076-12-06 (19th March, 2020),
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
